EULA

This Agreement, in conjunction with the receipt that accompanies each purchase from zansari.co.nz (Zansari) constitutes the complete agreement between you and Zansari.

1. Allowed uses

You are hereby granted a non-exclusive, non-assignable, non-transferable (except as expressly permitted herein) license to access, download and use the font.

Definitions

- Mobile app / game - A mobile app / game is a piece of computer software designed to run on a mobile device such as a phone / tablet or watch
- A desktop app is a piece of computer software designed to run on a computer such as a desktop computer or laptop.
- An electronic publication / book (or e-pub/e-book) is a book publication made available in digital form, consisting of text, images, or both, readable on the flat-panel display of computers or other electronic devices. These are commercially available to end users

The following are allowed by this agreement; you may:

- Use the fonts for commercial or personal purposes.
- Use the fonts for a single mobile, desktop app or game with no restrictions on app or game downloads
- Install and use the fonts on one secondary computing device, like a laptop or tablet, per licensed computer identified in section 1b. The person using the secondary device must be the same person using a licensed computer.
- Include a limited amount of rasterized or vector text and artwork in software or hardware applications provided the text or artwork does not result in all or substantially all of the characters comprising the font being shown in the digital documents. Examples of acceptable use include, but are not limited to, a logo or the text of static menu options set in the fonts.
- Embed the fonts into digital documents provided i) the font is subset, ii) the document text can be viewed and printed but not edited, and iii) reasonable measures are taken to ensure the embedded fonts cannot be extracted.
- Provide a copy of the fonts to a commercial printer or service bureau to reproduce a particular document.
- Make modifications to the outlines of the fonts, for example in Illustrator, so long as the modified outlines are not turned into a font of any kind or format.
- Make a reasonable number of backup copies of the fonts. Copies must contain the same documentation, copyright, trademark, and other proprietary notices that appear on, in or with the fonts.

All-encompassing principles of use

- This font may be used for one project only. A Project is defined as a complete and cohesive undertaking that may result in one or more End Products. Any End Products included in the one Project must be directly related under a single concept.
- This license is perpetual and will not need to be renewed with subsequent purchases in future.
- Hosting the fonts on your own or a third-party server and serve the fonts to websites is only permitted with the purchase of a webfont / digital ads or complete commercial license. Your license is not restricted by numbers of pageviews. A “pageview” is one request for the viewing of a page of a website.
- Use of the fonts in email campaigns with the CSS @font-face rule is only permitted with the purchase of a webfont / digital ads or complete commercial license. Your license is not restricted by numbers of pageviews. A “pageview” is one request for the viewing of a page of a website.

Under no circumstance is the font permitted to be on-sold.

- This includes;
 - Direct sale, sale of apps that contain this font without an app/game license
 - Bundling and creating templates/mock-ups without a business license

2. Number of users

There is no defined maximum number of desktop installations of this permitted. Hence you may install this font on as many desktop computers as you wish, provided that all installations support the single project for which this font license was purchased for.

3. Third parties

You may provide the font to a graphic designer, printer or other service bureau that is working on your behalf only if they agree to use the font exclusively for your work, agree to the terms of this license, and retain no copies of the font on completion of the work.

You may not provide the font or make it accessible to any other third parties.

4. Modifications

You may import characters from the font as graphical objects into a drawing program and modify such graphical objects.

You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the licensed font itself without Foundry's prior written consent.

5. Copyright

The font and the accompanying materials are copyrighted and contain proprietary information and trade secrets belonging to the foundry owning the font. Unauthorized copying of the Product even if modified, merged, or included with other software, or of the written materials, is expressly forbidden.

You may be held legally responsible for any infringement of the foundry's intellectual property rights that is caused or encouraged by your failure to abide by the terms of this Agreement.

6. Refunds

All sales are final and non-refundable, unless proven that the files are defective, after a period of exhaustive technical support and evaluation.

7. Misuse of fonts

Use of fonts without license or adequate licensing will require a license to be paid for the usage of the font software retroactively

8. Termination

This Agreement is effective until terminated. This Agreement will terminate automatically without notice if you fail to comply with any provision contained herein. Upon termination, you must destroy the written materials, the Product, and all copies of them, in part and in whole, including modified copies, if any.

EXCEPT AS EXPRESSLY PROVIDED ABOVE, THE PRODUCT, IS PROVIDED "AS IS". THE FOUNDRY DOES NOT MAKE ANY WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

The entire risk as to the quality and performance of the Product rests upon you. The Foundry does not warrant that the functions contained in the Product will meet your requirements or that the operation of the software will be uninterrupted or error free.

If the font does not perform substantially in accordance with the representations, Zansari will first work to fix the issue and offer replacement font files. If Zansari is unable to fix the issue, the entire and exclusive liability and remedy shall be limited to a refund of the license fee you paid for the fonts.
